TERMS AND CONDITIONS

Promotion Type: Draw

Dates: 02 September 2024 until discontinued.

Overview: Upon making a purchase at Shingle Inn Gladstone, customers can enter the draw to win a High Tea for four people valued at \$134. One winner will be drawn at random from the entry box on the third Wednesday morning of each month during the promotion. The winner will be notified by phone. The prize must be redeemed within one month of the draw date.

Draw days/time/prizes: One draw on the third Wednesday of each month commencing in September 2024. The draw will be conducted prior to opening time.
