



MID-WEEK MONEY RUSH PROMOTION TERMS AND CONDITIONS

Promotion Type: Gaming Promotion

Dates: ENTRIES COMMENCE 12:50PM-2:30PM WEDNESDAYS WITH THE FIRST PROMOTION ON WEDNESDAY 06 MAY 2026 AND CONTINUING EACH WEEK UNTIL FURTHER NOTICE

Overview: Entries accumulate in the virtual barrel for every \$5 win in gaming on the meter during the promotion times. One winner will be announced every 10 minutes from 1:00pm – 2:30pm (total 10 winners). Players must approach the promotion host within 3 minutes and play the Mid-Week Money Rush gameboard to win a cash prize.

Entry method:

1 entry for every \$5 win on the meter on a gaming machine between 12:50pm and 2:30pm Wednesdays. Players must have a player card inserted in a gaming machine to have entries awarded for wins.

Draw days/time/prizes:

Draws will occur on Wednesdays from 1:00pm to 2:30pm with the first draw day being Wednesday 06 May 2026 and continuing weekly until further notice. Players must be present at the time of the draw and approach the promotion host within 3 minutes to play the gameboard and claim a prize. The venue reserves the right to discontinue the promotion at any time.

Minimum prize pool each week that the promotion is run is \$200 in cash:

Play the Mid-Week Money Rush gameboard to determine the prize value. Players select two cards from the gameboard. If two identical symbols are found, the player wins the corresponding prize value.

- 2 x Diamonds = \$30
- 2 x Ace of Spades Cards = \$40
- 2 x Gold Crowns = \$50
- 2 x Bag of Gold Coins = Jackpot prize
- No matches = \$20 consolation prize

The Jackpot prize starts at \$100 and increases by \$50 each day it is not won.

Selected cards are returned to their position on the gameboard before the next player's turn. The Promotion Host reserves the right to reposition cards on the gameboard if they have reason to believe that the position of cards has been sighted and an unfair advantage could be gained by a player.
