



\$25,000 SPRING CHA-CHING PROMOTION TERMS AND CONDITIONS

Promotion Type: Gaming Promotion

Dates: 10am Monday 31 August 2026 – 10 October 2026

Overview: Players insert player card when playing a gaming machine to earn automatic entries into the virtual barrel draws to win a share in \$4,300 guaranteed cash each Saturday. Entries accumulate for every \$10 Win on the meter in gaming. Members must activate their entries into the draws by scanning their digital card at the kiosk from 12pm (midday) on draw days. Entries can be activated up to 10 minutes prior to each draw time. There are nine (9) guaranteed prizes each Saturday during the promotion period. Players must be present at the time of the draws and have 3 minutes to claim the prize.

Entry method:

\$10 Win on the meter in gaming: This promotion is open to app users only. Players will need to insert their player card when playing a gaming machine to earn entries into the virtual barrel draws.

Activate entries in guaranteed draws from 12pm on draw days: Players must activate their entries in the draws by scanning their digital card at the kiosk from 12pm on draw days. Entries continue to accumulate up until the final draw of the day. Entries do not accumulate week to week.
